



### **Rejecting the Blame Game**

This morning, a writer friend texted about a book they're reading that shares some aspects with their own WIP. They were a little worried. Is it too similar? Would they be accused of copying the other book's author?

We talked it out, and though the books share some common elements, the subject matter is treated differently enough that it's probably not a problem. But even as we discussed the matter, I thought of two books coming out soon, both of which share common elements with my own WIP.

Do I worry about this? Yes. Not so much that someone would think I'd copied them—and if so, I have plenty of evidence showing I've been working on this damned book since late 2013. But I hate knowing that what seemed like a fresh idea a decade ago (God, it's painful to even write that) is now not so fresh. And I only have myself to blame.

Wait a second. Is blame the right word? Sometimes, when I'm feeling particularly down on myself, blame is the only word that fits. But the book I began writing so long ago is a completely different book now and one that I feel good about. Can I really give myself grief when the book is better now (though still unfinished)?

It depends on the day.

SoCalMWA members represent a range of writers. Some have been in this game for a long time and have their work and careers handled. Others, like me, have some experience but may not have reached their goals. And still others are beginners, excited to be on this path but sometimes uncertain about where it will lead. Indeed, there's probably a bit of each type in all of us, no matter our experience.

I sometimes get confessional here, hoping it will resonate with at least some of you. I don't make a habit of quoting Michael Jackson, but "You are not alone."


**Jeri Westerson** is launching her second new series this year, *The Isolated Seance*, in her An Irregular Detective Mystery series, a Sherlockian pastiche.




